- Events Delivering the highest quality events for competitors, officials and volunteers
  - Welsh Cadet Championships February 2023
  - Welsh National Championships February 2023
  - Welsh Team Championships February 2023
  - Cadet ADP & BYC Qualifiers March 2023
  - Welsh Veteran Championships September 2023
  - Youth ADP (N Wales) October 2023
  - 6W Cadet BRC July 2023
    - The only 6W cadet event outside the British Championships
    - Entry 185 (2022), 193 (2023)
    - One of the first ranking events of the season
  - Welsh Open November 2023
    - Largest entry in recent history
    - Premier for Wheelchair Fencing 19 Competitors

- UKAD
  - Continued adherence to the requirements of the Framework
- Development and Profile of Wheelchair fencing in Wales
  - Para-sport festival July 2023
    - Held the British Wheelchair Championships
  - Welsh Open
  - Supporting BF bring the Wheelchair Fencing World Cup to Wales in Jan 2024
  - Attending INSPORT events run by Disability Sport Wales Introducing fencing to disabled children, young people and adults



- WF continue to adhere to the governance requirements of Sport Wales to ensure our continued funding
- Full financial review with Sport Wales



- Maintained current levels of financial support from Sport Wales
  - Challenging given the Welsh Government's fiscal situation and increased focus on NHS, transport and social care
- Recognised for 5-year planning process and surplus/deficit cycle
- £18k capital investment from Sport Wales to enable our ambitions to better support para-fencing in Wales
  - 2 x wheelchair frames purchased
    - Located in Cardiff & Wrexham
  - Specifically designed fencing wheelchairs in final stage of development with RMA Bridgend




- Cadet & Junior Commonwealth Championships New Zealand
